

ERGODICITY PROPERTIES OF 2-PARAMETER MARKOV COLLISION PROCESSES WITH RESURRECTION

Abstract: This paper concentrates on investigating ergodicity properties of 2-parameter Markov collision processes with resurrection. Easy checking criteria including several clear-cut corollaries are established for ordinary and strong ergodicity of such processes. The equilibrium distribution is given in an elegant closed form for the ergodic case. As a preparation, the criteria for regularity and uniqueness for such structure are also established.
